# Introduction

Public sector decisions significantly affect Visa's business and the payments industry. For this reason, Visa participates in the political process around the globe in the many jurisdictions where it conducts business through regular and constructive engagement with government officials and policymakers, by encouraging the civic involvement of our employees, and by contributing to political organizations and U.S. state and local candidates, where permitted by applicable law.

Visa is committed to conducting these activities in a manner that reflects responsible corporate citizenship and best serves the interests of our shareholders, employees, and other stakeholders. Visa's Government Engagement team manages the Company's political engagement in accordance with the requirements under the Visa Inc. Political Participation, Lobbying, and Contributions (PPLC) Policy, which is overseen by the Nominating and Corporate Governance Committee and was established to:

- · Promote ethical and transparent political engagement by Visa,
- · Ensure that our political spending enhances shareholder value,
- · Facilitate our compliance with applicable laws and reporting requirements; and
- Align our government engagement activities in support of Visa's corporate purpose to uplift everyone, everywhere by being the best way to pay and be paid.

This report contains information regarding Visa's advocacy activities and trade association memberships, corporate political contributions, and Visa Political Action Committee (PAC) contributions for the calendar year 2024.

### Advocacy, Lobbying, and Political Compliance

Around the globe, Visa engages with governments and policymakers on various topics ranging across governments and spanning multiple payments industry matters. Key issues include electronic payments, technological and payments innovation, cybersecurity, digital services, artificial intelligence (AI), data and privacy, digital public infrastructure, financial inclusion, international tax, cross-border commerce, and market access, among others. In addition, Visa advocated on matters related to small business, financial literacy and education, consumer protection, and workforce development.

### **Political Compliance**

Visa complies with international, national, state, and local laws concerning lobbying registration and reporting. Outside of the U.S., Visa files lobbying disclosure reports in Canada.

At the U.S. federal level, quarterly lobbying disclosures are filed with the U.S. Congress disclosing Visa's federal lobbying expenditures and the issues lobbied. In 2024, pursuant to the Lobbying Disclosure Act, Visa reported a federal advocacy (lobbying) total expenditure of \$7.72 million. Visa also files semiannual contribution reports in January and July, which are also available in the online databases discussed above.

## **Trade and Business Associations**

Visa belongs to a variety of trade associations, coalitions, and industry organizations in the U.S. and abroad and pays regular dues to these groups. Visa is a member of these organizations to advance the Company's corporate purpose and promote its business interests and objectives. However, Management recognizes that the Company will not always support all of the public positions of those associations or of the diverse companies that make up their membership. Management reviews the continued appropriateness of maintaining these memberships at least annually.

As part of this report, below is a list of the names of all U.S. trade associations to which Visa paid annual membership dues that are \$25,000 or more. If Visa is advised that any portion of the Company's trade association dues were used for political purposes, such activity would be included in the corporate political contributions section of this report. In 2024, the combined amount of U.S. trade association dues attributed to federal lobbying activities totaled approximately \$1.61 million.

### **Corporate Political Contributions**

Visa makes corporate political contributions in strict compliance with applicable laws and the PPLC Policy. While corporations are not permitted to contribute to U.S. federal political campaigns or to national political parties, they can contribute to state and local candidates in many jurisdictions and 527 organizations. This report includes all applicable corporate contributions made by the Company, including any payments to U.S. tax-exempt organizations engaged in advocacy (including 501(c)(3), (4), and (6) organizations) if Visa determined that the contribution in question was used for political activities.

- In the United States, Visa makes contributions to state and local candidates and ballot measures in the U.S., trade associations to support targeted political campaigns, organizations registered under Section 527 of the U.S. Internal Revenue Code.
- Outside of the United States, Visa supports political parties and business forums in the Asia Pacific and Europe regions.

Visa contributes financially to candidates evaluated based on the following criteria:

- Views, voting record, and understanding of policy issues of importance to the Company, its shareholders, and other stakeholders;
- Reputation for integrity;
- · Service in a party or legislative leadership position;
- Relationship to or representation of a Company facility or a large concentration of Company employees; and
- · Commonality in the Company's legislative priorities.

With respect to both state and local contributions made by the Company as well as contributions to federal candidates made by the Visa PAC (discussed below), the Company recognizes that any contribution made to a candidate or political organization does not mean Visa endorses all of that candidate's or organization's views. The Company reserves the right to discontinue support of any contribution recipient.

Political contributions will not be given in anticipation of, in recognition of, or in return for, any official act and corporate funds may not be used for any unlawful, improper, or unethical purpose.

#### 2024 Visa Corporate Political Contributions

The following pages include a list of political contributions<sup>1</sup> Visa made in the U.S. and abroad during calendar year 2024. The political contributions listed are aggregated on a yearly basis and may reflect contributions to multiple campaign committees associated with a single legislator and may reflect primary and/or general election contributions and party conferences.<sup>2</sup> No trade association advised Visa that any of the company's dues were used for political expenditures in 2024, unless otherwise listed in the report.

# **Visa PAC Contributions**

In the United States, Visa also sponsors a federal PAC pursuant to the Federal Election Campaign Act, as amended, and the regulations promulgated by the Federal Election Commission. The Visa PAC enables Visa employees to voluntarily pool their financial resources to support federal candidates and federal party organizations.

The Visa PAC is governed by its board of directors, which appoints the officers of the PAC and supervises and directs the PAC's administration, solicitation campaigns, contributions, and compliance with applicable law and the PAC Bylaws.

Recipients of Visa PAC contributions are selected based upon the same criteria referenced under the Corporate Political Contributions section of this report, and any other factors the Visa PAC Board may develop. In addition to the below list, Visa PAC contributions and expenditures are publicly disclosed on the Federal Election Commission's website (<u>www.fec.gov</u>), where they can be accessed by searching "Visa Inc. Political Action Committee" in the Committee name field.

### 2024 Visa PAC Contributions
